



## **“MEXICAN STYLE” HITS SOUTHERN CALIFORNIA COAST!!**

### **FIGHT WEEK MEDIA EVENTS HEADED TO SANTA MONICA, MANHATTAN BEACH AND CARSON, CALIFORNIA**

Los Angeles, CA (October 9, 2014) The Southern California coast will come alive with *Fight Week Media Events* leading up the highly anticipated **“Mexican Style”** world championship boxing event set for **Saturday, October 18th** at the famed **StubHub Center** in Carson, California.

**“Mexican Style”** is headlined by *Boxing’s fastest rising star*, **GENNADY “GGG” GOLOVKIN**, 30-0-0 (27KO’s) defending his WBA and IBO Middleweight World Titles against WBC Interim Champion **MARCO ANTONIO “EI Veneno” RUBIO**, 59-6-1 (51KO’s) in the 12-round main event.

Co-featured is a featherweight showdown between 2012 Fighter of the Year and four-division world champion **NONITO “The Filipino Flash” DONAIRE**, 33-2-0 (21KO’s) and undefeated world champion **NICHOLAS “The Axe Man” WALTERS**, 24-0-0 (20KO’s) who will battle it out to determine the undisputed WBA featherweight world champion.

Both world title fights will be televised **Live on HBO World Championship Boxing®** beginning at 10:00 p.m. ET/PT.

On **Wednesday, October 15**, all four HBO fighters will hold outdoor *Media Workouts* at the **220 Boxing Academy** in Santa Monica, starting at 12:00 p.m. PT.

The *Final Press Conference* for **“Mexican Style”** will take place at 12:00 p.m. PT on **Thursday, October 16** at the **Manhattan Beach Marriott**.

Starting at 12:30 p.m. PT on **Friday, October 17th**, the **StubHub Center** Concourse will play host to the *Official Public Weigh-In*.
